From Rabbi Kogan

Dear Friends of Hillcrest Jewish Center,

You probably heard some jokes about dogs in shul. There is this dog who is having his "bark mitzvah," the dog who is so knowledgeable that should be a rabbi, but wants to be a doctor, and the rabbi who allows the dog to have a bar mitzvah for a \$100,000 donation.

Those who come regularly to Hillcrest Jewish Center, however, are accustomed to seeing dogs in shul. We all remember *Jack*, Janet's loyal seeing eye dog, and now we all know *Pete*, her new dog. Ilana comes to shul with *Tricia*, and occasionally we get a visit from *Honey*, when Karen joins us for evening minyan.

A few weeks ago, I came across a rabbinic response about service dogs on Shabbat. While I am mindful that not everyone at Hillcrest Jewish Center is meticulously observant of the many Jewish laws, I believe you will find the responsa enlightening.

Can you use a service dog on Shabbat?

Service dogs have become more accepted throughout the country in places where dogs are often not allowed. A service dog is a type of assistance dog specifically trained to help people with certain difficulties such as visual impairments, hearing impairments, mental illnesses (such as posttraumatic stress disorder, seizure disorder, mobility impairment, and diabetes.) They can be trained to help the person get something that they can't reach, and they can even detect when the person has a seizure and get help.

A few years ago, when I visited Dogs for the Deaf in Oregon (since renamed Dogs for Better Lives), it was amazing to see how these dogs are trained and how helpful they can be. It should be noted that this is different than an emotional support dog. Service Dogs are highly trained and certified to do certain tasks for their owners.

Technically, according to the Torah one would be allowed to ride a horse on Shabbat since it does not violate any one of the 39 *melachot* (*forbidden labors*). However, the rabbis forbade it as they were concerned that one may, without paying attention, pull a branch from a tree to fashion a whip to hit the horse with. Pulling a branch is forbidden on Shabbat as it is one of the 39 forbidden labors. Therefore, Maimonides writes that one may not ride on an animal on Shabbat and one may not use the animal in any way such as to hang things on it or to just sit on it. The Shulchan Aruch – main code on Jewish law – rules that animals are *muktze* and one may not lift them or move them on Shabbat. One may place food in front of them but cannot carry them. The Shulchan Aruch also writes that one may walk a dog on Shabbat by holding the leash and even leading the dog.

Rabbi Yitzhak Yosef adds that for a service dog, in addition to the above, there is even more reason to permit its use. As noted above, even riding an animal is rabbinically forbidden, not biblically forbidden. Therefore, for an ill person it would be allowed, especially since he is not riding the animal and only using it for help.

A related question is what to do about neutering the service animal. The Torah forbids sterilizing any male living animal or person. Some rabbis have allowed one to tell a non-Jew to do it, in cases of need. Others only allow one to purchase an animal that was previously neutered, but not to go and specifically tell a non-Jew to do it. Rabbi Shlomo Amar, former Chief Sephardic Rabbi of Israel, had famously allowed telling a non-Jew to do it for you, for purposes of public safety, since so many people own pets today. Another question would be whether a blind person can bring his service dog to synagogue on Shabbat (or any other day of the week). Rabbi Moshe Feinstein writes that it is permitted based on a passage in the Talmud. In tractate Megilah of the Jerusalem Talmud Rav Ami states that if a rabbi visits a synagogue, he may sleep in it, and he may bring his donkey and other belongings in as well.

Rav Moshe Feinstein therefore writes that if a donkey is allowed in, then a dog should be allowed in as well, especially if it is to give someone the ability to come to synagogue who could otherwise not have that ability. Rabbi Ratzon Arusi, in a similar issue, writes that synagogues are required, if they can afford it, to be wheelchair accessible. He writes that it is very important that all synagogues be as inclusive as possible and should accommodate community members when possible.

REPORT FROM THE BOARD OF TRUSTEES

Shalom fellow congregants. Here are some highlights from our May meeting:

--Sisterhood ran 2 events in May and is celebrating its 85th year starting June 1st.

--Men's Club invites everyone to the annual fishing trip on June 23rd and to the NY Mets game on July 10th vs. the Washington Nationals.

--Youth and Family is currently implementing a six-part plan to revitalize the program and attract more kids. Two monthly dinners for the Junior Congregation and for teens are planned at the Rabbi's house and in the Moreida.

--The following motion passed: For employees who receive health benefits from HJC and become eligible to receive Medicare, Hillcrest will reimburse their Medicare costs (if any) and continue their Hillcrest provided health insurance as their secondary insurer, as long as the combined cost to Hillcrest does not exceed the current cost of insurance for a non-Medicare employee.

--The Board approved the salary increases for office and maintenance employees for the 2024-25 fiscal year.

--The Executive Director's contract was approved.

--The Cantor's contract is being worked on.

--The sale of the building has been a slow process and we are still waiting for feedback and comments from the lease review of the HJC real estate professional committee.

--Security protocols were discussed including the need for guest lists to be provided for all events.

--Approximately two-thirds of the congregation has already paid the security assessment. Thank you to those who have already paid. We are looking forward to 100% participation.

--One of our boilers needs to be replaced. Quotes have been received and the board voted on funds for the replacement.

--A Web designer has been hired. A donation page will be up in the next few weeks. We are working on the capability of allowing members to sign into personalized accounts.

--The recent security email: At the May Board of Trustees meeting, the Security Committee reminded board members that in order to encourage safety, the only entrance and exit that all congregants should use is the **Roberts Building door** that leads to the main office or Sanctuary. Please be mindful of this and do not use the Moreida exit after kiddush on Shabbat. If you need to use the ramp located in the

parking lot to enter or exit the building, please inform Frank, Alan, or Harold to ensure secure entry and exit. Thank you for helping to keep us all safe.

After 16 years of providing a high-quality religious foundation for our community's children, our school has been forced to close its doors. However, until our very last day, our teachers would not allow our standards to flag one iota and the students were able to enjoy their last lessons with us.

On May 5th, our Giborim and Chaverim students were able to learn about the lives of their contemporaries and their families during the Holocaust. Yael Rozic, a former docent at Yad Vashem, spoke with our youngsters about life in Terezin, a concentration camp which was considered a "model camp", the one which was shown to Red Cross visitors to demonstrate that life was idyllic during the Shoah.

Perhaps one of the milestones in our students' academic years at Ohr Chadash was when they receive their first personal siddur. Morah Marina's success with Giborim students was evident on May 12th, when family members were able to witness their capabilities at our Siddur Presentation program.

For our final day, our children were able to celebrate an early commemoration of Lag B'Omer. They started the morning in the HJC main ballroom, enjoying various tabletop activities and games of skill, followed by relay races and tug o' war. Their appetites now sufficiently whetted, they proceeded to the Moreida area for the Barbecue. Thank you to Harold Moskowitz who served as our BBQ chef extraordinaire.

Ohr Chadash always extended its appreciation to the host synagogue for accommodating our needs and adjusting its schedule to provide us with the necessary locales for our programs and our teaching necessities. Our gratitude for this term and the numerous occasions we were on site at HJC is extended to the office staff, headed by Juana and Melissa, the custodial staff, especially Orlando, the executive director, Nadine, and all personnel who helped make our stays thoroughly pleasant experiences. Our hearts and warm memories go out to Cantor Moti Fuchs, whose love for our children and their efforts was always evident. He was one of a kind.

For more than a decade and a half Rabbi Kogan and Rabbi Wise have been Ohr Chadash's chief cheerleaders. To the Ohr Chadash School Board throughout the years, thank you for your faith and support.

My last words go out to Morah Judy, Morah Marina, Morah Zehava, and Moreh Marc. Thank you for making our last year as vital as our first. Morah Judy, my mentor, friend, and right hand, always there for advice, confidence, committed to our children and school.

Thank you to our school board and our families for allowing me the pleasure of being part of Ohr Chadash for all these sixteen years. I will forever be the richer for my experiences here and I will always carry the smiling faces of our students in my heart.
